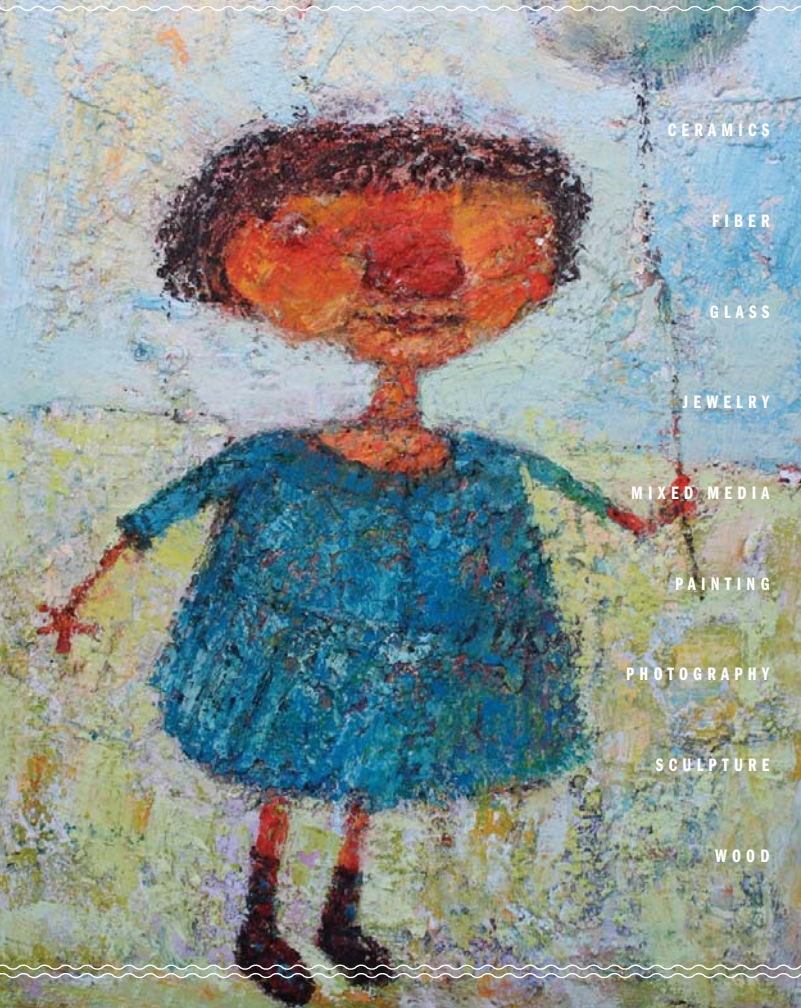

Eligibility

All work must be executed by the applicant. Acceptance is based solely on slides or digital images submitted. Decisions of the Selection Committee are final. The Selection Committee reserves the right to prohibit exhibition of unsuitable works. We reserve the right to re-jury any new work at the time of the show.

Fees

JURY FEE: \$20.00 (non-refundable) | **SPACE FEE:** \$250.00 (non-refundable upon acceptance/no exceptions)

Slide jury

- All artists must submit examples of work. Slides or a CD of digital images are acceptable (do not email images). Please include four examples representing your current work and one showing your booth display. The work you exhibit should be consistent with your slides/images.
- If submitting slides please: place all slides in a plastic sleeve labeled with your name. In addition each slide must be labeled with your name, medium, size, top and a red dot in the lower left corner.
- If submitting a CD: Please burn all images to one disk labeled with your name and medium.
- Describe each work represented.
- List the names and locations of juried art fairs in which your work has been recently exhibited.
- Please include self-addressed stamped envelope (required).

Deadline Notification

Entries must be postmarked by July 16, 2010. Notification of acceptance will be mailed by August 9, 2010 (checks will be deposited on August 9). If your work is accepted, your slides or CD of digital images will be returned to you at the Arts Fest. If your work is not accepted, your uncashed booth fee and slides/CD will be returned promptly.

Display Specifications

Artists must provide their own tents, racks, tables, chairs, and other display equipment. Electricity is not available. Booths must look professional. Artists must be present.
